**Agreement Details:**

**1. Space and Setup:** Oceanside Community Warriors will provide the vendor with a designated space at the festival for the purpose of selling goods/services, no larger than 11' x 11'. The vendor is responsible for setting up and maintaining their booth or space, including disposal of garbage in appropriate receptacles. Setup must be complete by 11:30 a.m., and tear-down cannot occur prior to the agreed-upon time. Vendors must provide their own tents, tables, chairs, and any other items required for setup. Electricity will not be supplied. Please note: vehicles will not be permitted to enter the festival parking lot — all equipment and supplies must be transported by hand or cart from designated drop-off areas.

**2. Products/Services:** The vendor agrees to provide the following products/services at the festival:

**3. Fees and Payment:** The vendor agrees to pay Oceanside Community Warriors the agreed-upon vendor fee of \$100 for the use of the designated space. If you have not already done so, please send checks made payable to Oceanside Community Warriors to 7 Hampton Road, 2<sup>nd</sup> Floor, Oceanside, NY 11572. **4. Insurance and Permits:** The vendor is responsible for obtaining all necessary permits, licenses, and insurance coverage required to participate in the festival. Proof of insurance and permits must be provided to Oceanside Community Warriors prior to the event. Please email all documentation to [info@oceansidecommunitywarriors.com](mailto:info@oceansidecommunitywarriors.com) by September 12.

**5. Compliance with Laws:** The vendor agrees to comply with all federal, state, and local laws and regulations applicable to their business, including health and safety standards.

**6. Cancellation:** In the event of vendor cancellation, any payments received will be considered a donation to the charitable organizations associated with the festival.

**7. Liability:** The vendor assumes all liability for their products/services and any actions or omissions by their staff or representatives. The vendor agrees to indemnify and hold harmless Oceanside Community Warriors from any claims, damages, or liabilities arising from their participation in the festival.

**8. Termination:** Oceanside Community Warriors reserves the right to terminate this agreement and remove the vendor from the festival if the vendor fails to comply with the terms of this agreement or engages in conduct deemed harmful to the event or its attendees.

**9. Governing Law:** This agreement will be governed by and construed in accordance with the laws of New York, US and any disputes will be resolved through arbitration or mediation.

**10. Entire Agreement:** This agreement constitutes the entire understanding between Oceanside Community Warriors and the vendor and supersedes any prior agreements or understandings, whether written or oral.
